With reference to the above, I am by direction to inform the following:

- The Fee for each Doctoral Committee Meeting is revived as follows with **immediate effect:**  
To the University – Rs.2, 500/- instead of Rs.3, 000/-  
To the Colleges – Rs.2, 500/- instead of Rs.2, 000/-
- The Penalty of Rs.500/- per year will be collected from the scholars at the time of submission of Thesis, for not following stipulated period as per guidelines for the completion of course work, conduct of Doctoral Committee Meeting, etc.,
- Standard A4 size paper not lower than 80GSM should be used for printing the Ph.D. thesis instead of bond paper.
- Sitting fee Rs. 500/- plus T.A (if necessary) as per norms has to paid to the Doctoral Committee Board members (Supervisor, Co-Supervisor (if any) and two Doctoral Committee members).
- Copy of the attendance sheet in the attendance register (attested by the Head of the University department / Head of the department and Principal of the College) should be submitted to the University along with the Bi-annual report.

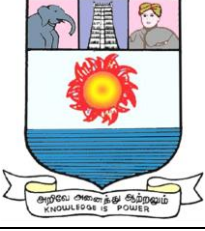

The Panel of Examiners should be in the following pattern:

- (i) **Three** Foreign Examiners from different regions and for Tamil the choice of different regions is optional.
- (ii) **Three** Examiners from outside Tamil Nadu i.e.,  
**Two** Examiners from South Region (different states) and **One** Examiner from North Region.
- Or**
- One** Examiner from South Region and **Two** Examiners from North Region (different States).
- (iii) **Three** Examiners within Tamil Nadu i.e.,  
**Two** Examiners from different State Universities / Different Colleges  
(1 Professor, 1 Associate or Assistant Professor)
- and**
- One** Examiner from Central Government funded Universities or Research Institutes.

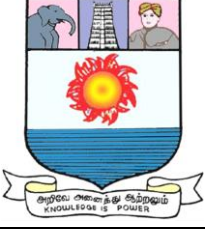

- The Fees Structures are revised as follows:
  - (i) Thesis Submission Fees: Rs. 15,000/-
  - (ii) Ph.D. Viva Voce examination fees:
    - Offline - Rs. 12,000/-
    - Online - Rs. 15,000/-

**Note:** The foreign evaluation is optional for the previous session scholars except for the remaining RNG, 'C' & 'B2' category and the above revised fees shall be applicable to them also.
