

- The acknowledgement for submission of Ph.D thesis will be issued and the vacancy will be created for the concerned guide only on submission of all necessary documents including Evaluation Panel.
- Duration for each particular work during the Ph.D Programme as given in the guidelines will be followed strictly otherwise it will be viewed seriously.
- Each Ph.D Scholar should have thorough knowledge in the guidelines available in the University Website and watch the University Website periodically([www.msuniv.ac.in-Research](http://www.msuniv.ac.in-Research) link – circular/announcements.)
- Fifteen days time as mentioned in the Viva Voce Communication for Viva Voce notification should be counted correctly and the documents as per the checklist mentioned in the Viva Voce communication should be submitted promptly and perfectly.
