PROCEDURE FOR OBTAINING UGC COMPLIANCE CERTIFICATE

AS PER UGC 2009 REGULATION

- First of all, the candidate has to submit a requisition letter forwarded by his/her Guide for getting UGC Compliance Certificate as per UGC 2009 Regulation.
- **★** The following Xerox copies of certificates of the Candidate must be enclosed with requisition letter:
 - Date of Commencement Order (University order stating the Registration number)
 - Ph.D. Provisional.
 - Title Page of Thesis (Attested by the Guide).
 - The candidate must have two publications based on his/her research work. (one from Refereed Journal and another one from any other journals (i.e. they must have been published before the conduct of Viva-Voce Examination). Evidence of both publications attested by the Guide must be enclosed with the certificate of his/her Guide (Format enclosed).
- Evidence of two Seminars/Conferences presentations based on his/her research work. (i.e. they must have been presented before the conduct of Viva-Voce Examination). The following evidences related with Seminar/Conferences must have been enclosed with the certificate of his/her Guide (Format enclosed). They are:
 - a) Seminar/Conference Presentation Certificate.
 - b) Seminar/Conference Proceeding's Title page.
 - c) Presentation title in the content page (must be highlighted).
 - d) Abstract of the presentation.

ORDINARY & TATKAL SCHEME OF FEE:

This University has introduced a new <u>TATKAL SCHEME</u> to enable the scholars to obtain UGC Compliance Certificate within a day or two. Accordingly, the scholars have the following option to choose.

- ❖ The fee for getting UGC Compliance Certificate in <u>Ordinary Scheme</u> has been fixed as Rs.3.000/- (Rupees three thousand only).
- ❖ The fee for getting UGC Compliance Certificate in <u>Tatkal Scheme</u> has been fixed as <u>Rs.7,000/-(Rupees seven thousand only).</u>
- ❖ Payment of fee shall be made through either Demand Draft drawn in favor of Registrar, Manonmaniam Sundaranar University, Tirunelveli-12 or Indian Bank Challan (Green Colour) situated in M.S.University campus, Abishekapatti, Tirunelveli.

NOTE: On the fulfillment of the above conditions only, the UGC Compliance Certificate will be issued. Hence, the candidates who require the said certificate are requested to apply by following the procedures mentioned above.
