

# Nature and Extent of Involvement of Faculty and Students in Academic Affairs / Improvements

BoS of Computer Science constitutes by members from other institutes, Industry experts, inviting area academicians from other leading institutions. There by the curriculum of the department is made state of the art mandatory credits earned through NPTEL & MOOC courses are greatly encouraged.

Job oriented, skill based and courses with focus towards entrepreneurship are included n the curriculum. To encourage teaching & Research skills UGC NET, GATE and Tamil Nadu state council for Higher Education recommended syllabus are consulted to draft the ME (Computer Science & Engineering) & MCA curriculum.

So that the Department of CSE Curriculum enriched with Job oriented, entrepreneurship oriented, Research & Higher Studies Oriented, Self Oriented skills.

#### Mechanism / Norms and Procedure for democratic / good Governance
