Examination & Evaluation	<ul style="list-style-type: none"> • All the programmes offered through Directorate of Distance Education are conducted with Credit System as specified by the UGC-DEB Open Distance Learning norms, 2017. • Before commencement of University examination, students are assessed for Internal Assessment. • The evaluation system is maintained as per the norms of the regular examinations of the University. • Evaluation of answer scripts are drawn from the panel of examiners available for the corresponding disciplines in the regular mode.
